The question "Are skill-based courses useful for job or business provided in the curriculum?" is an important question that assesses the practicality and relevance of the courses offered by the institution. The table shows that out of the 3092 respondents, 2666 students responded "Yes" and 426 students responded "No".

The fact that the majority of students responded "Yes" suggests that skill-based courses provided in the curriculum are perceived to be useful for job or business. This is a positive result, as it means that the institution is offering courses that are relevant to the needs of students and the job market.

However, the fact that 426 students responded "No" suggests that there may be some issues with the relevance or effectiveness of some of the skill-based courses being offered. It is important for the institution to identify the specific areas where students are struggling and take steps to address these issues. This could involve reviewing and revising the curriculum to ensure that it meets the needs of students and the job market.

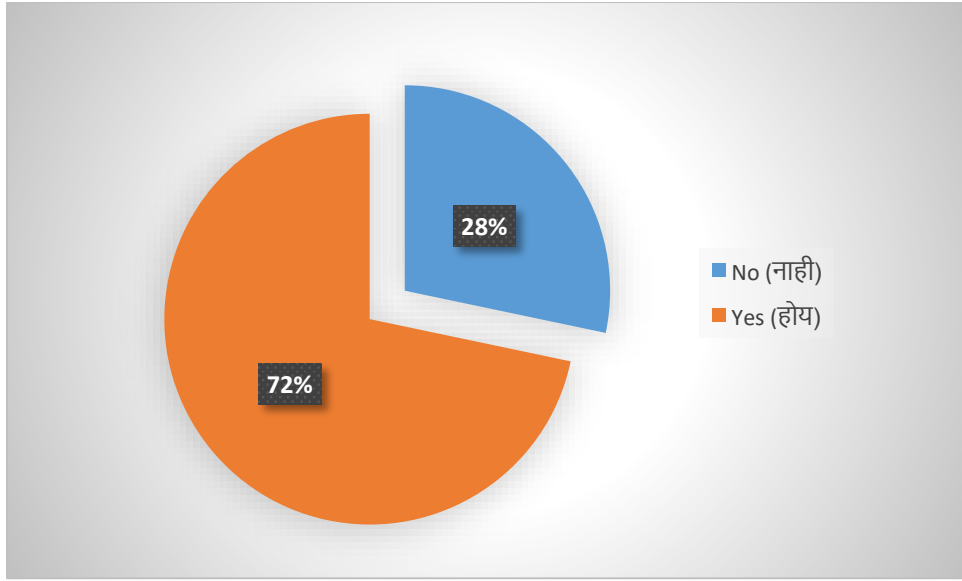
It is also worth noting that the number of students who did not respond to the question is relatively small, which suggests that most students have a clear

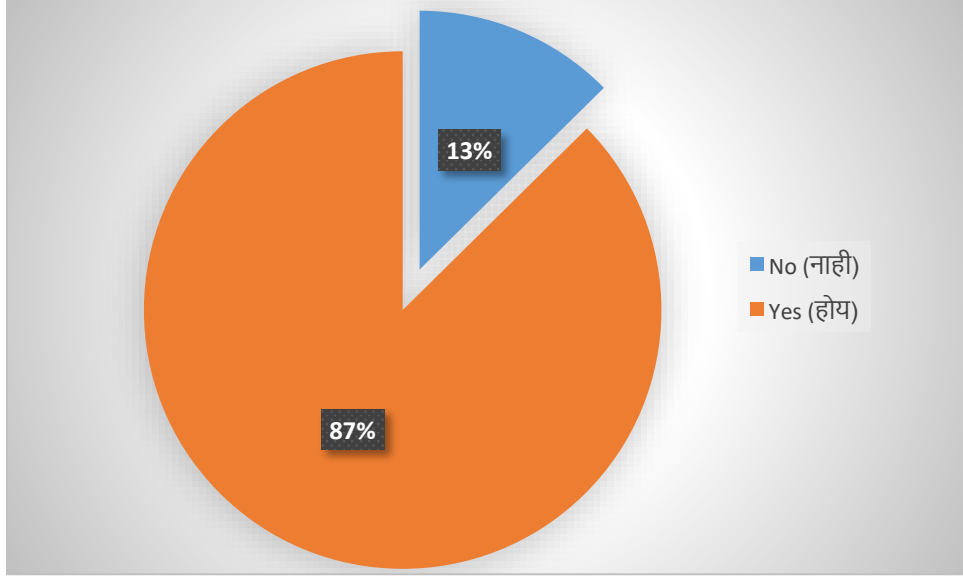

According to the responses received from students, it appears that a majority of students (approximately 72%) have had some points in the curriculum taught with the help of ICT (Information and Communication Technology). However, around 28% of the students indicated that they have not had any points in the curriculum taught with the help of ICT. This suggests that while there is some integration of technology in the teaching process, there is still room for improvement to ensure that all students have access to such methods of learning. 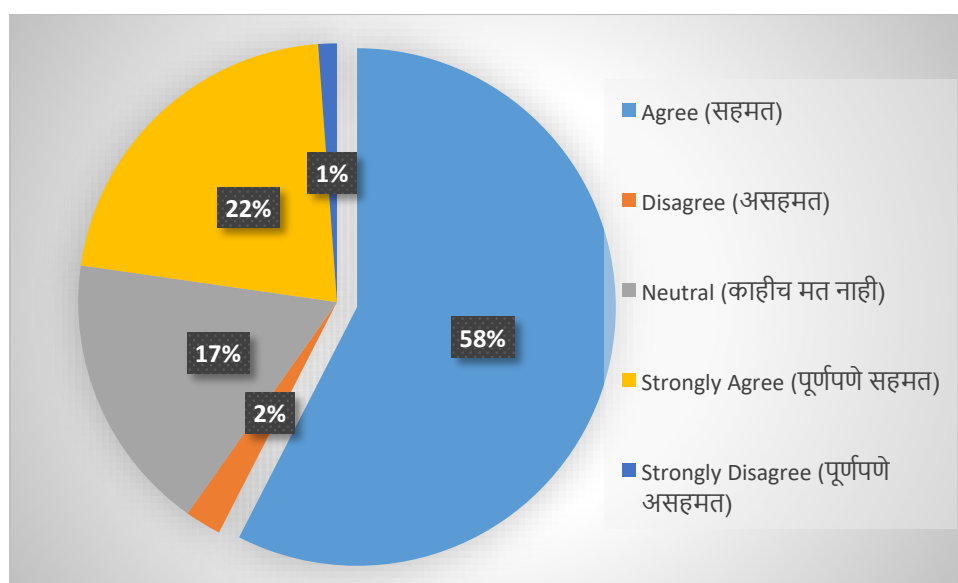


According to the responses received from students, it appears that a majority of students (approximately 87%) believe that the curriculum gives them sufficient and necessary knowledge with respect to future career opportunities. However, around 13% of the students indicated that they do not feel the curriculum is sufficient in providing them with the knowledge they need for their future career. This suggests that while the majority of students are satisfied with the curriculum, there is still a minority that may feel that more needs to be done to ensure that they are adequately prepared for their future career paths. It is important for educators to consider the feedback provided by the students and to make adjustments as necessary to ensure that all students feel prepared and equipped for their future endeavors.

The question has two parts: one about the learning value and the other about the depth of course content.

For the first part, a total of 2986 responses were received, out of which 1779 respondents agreed that the learning value (in terms of skills, concepts, knowledge, analytical abilities, or broadening perspectives) are well addressed in the syllabus. Only 70 respondents disagreed with this statement, and 540 respondents were neutral. 667 respondents strongly agreed with this statement, while 36 respondents strongly disagreed.

For the second part, the same respondents were asked to rate the overall syllabus on a five-point scale. A total of 2986 responses were received, out of which 1779 respondents agreed that the depth of course content is good. Only

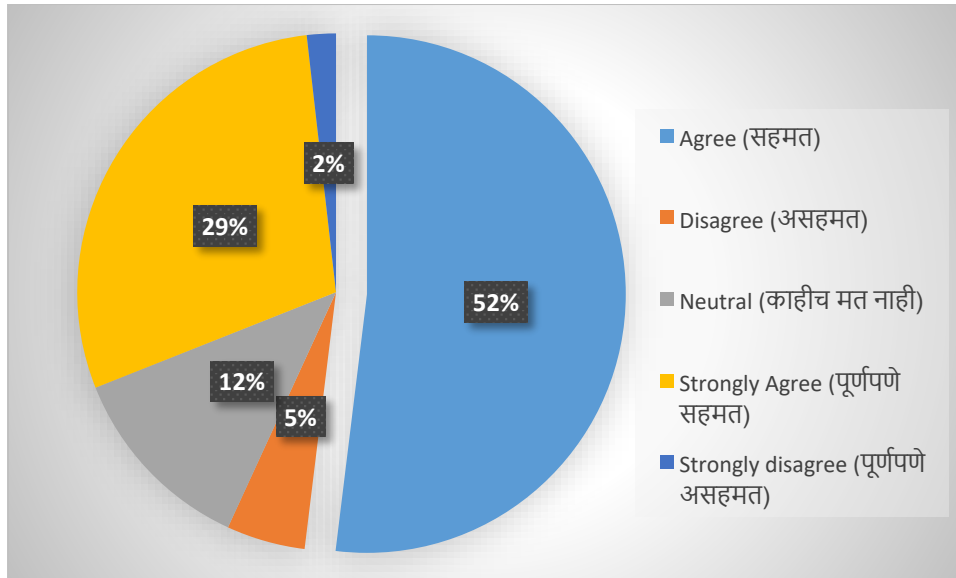
70 respondents disagreed with this statement, and 540 respondents were neutral. 667 respondents strongly agreed with this statement, while 36 respondents strongly disagreed.

Overall, the responses indicate that the majority of students agree that the learning value and depth of course content in the syllabus are good. A small percentage of respondents disagreed or were neutral, suggesting that there may be areas for improvement in the curriculum.

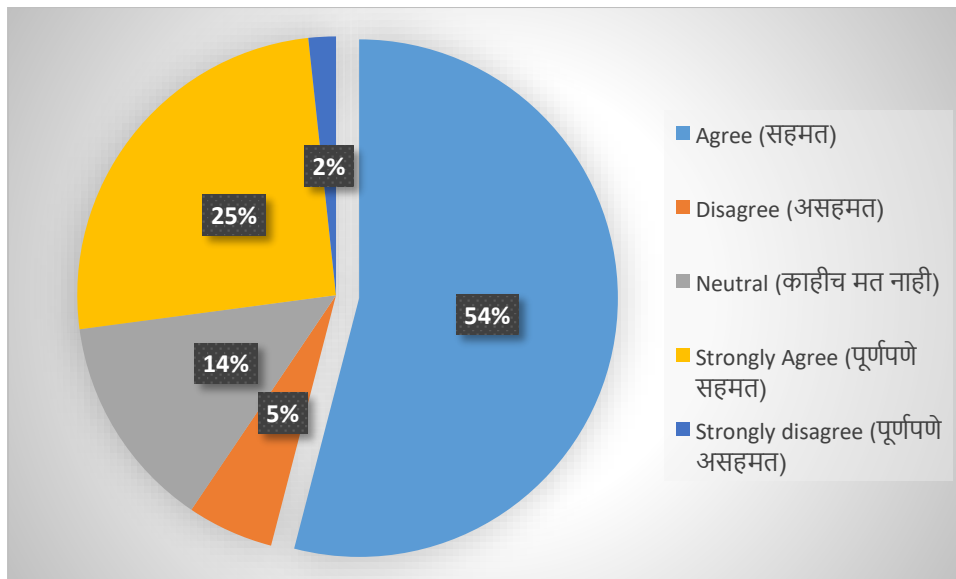
Out of 3092 respondents, 1606 (52%) agreed that the syllabus has applicability/relevance to real-life situations, and 903 (29%) strongly agreed with the statement. On the other hand, 152 (5%) respondents disagreed, and 56 (2%) strongly disagreed with the statement. Additionally, 375 (12%) respondents had a neutral stance.

This indicates that a majority of the students feel that the syllabus has practical relevance in real-life situations. The high number of respondents who strongly agreed with the statement suggests that they find the syllabus particularly relevant and applicable to their future careers. However, there is still a small percentage of students who disagree with the statement, indicating that some feel that the syllabus may not be as applicable or relevant to their real-life situations. Based on the responses received from students, we can analyze the question "Is the syllabus sufficient to make you analyze the problems and its suitable solutions?" as follows:

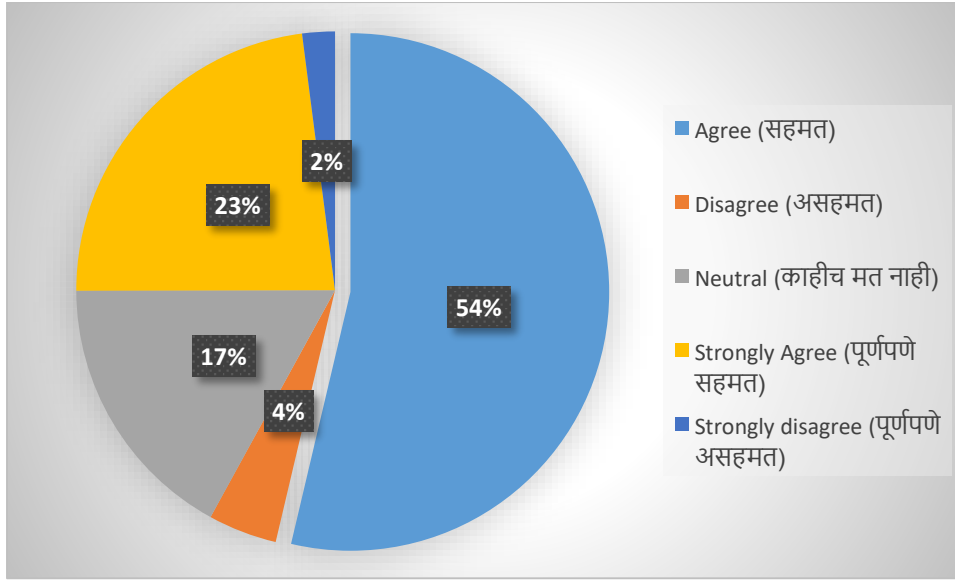
Out of the 3092 students who responded, 1671 (54%) agreed that the syllabus is sufficient to make them analyze problems and their suitable solutions, while 167 (5%) disagreed. 785 students (25%) strongly agreed with the statement, while 53 (2%) strongly disagreed. The remaining 416 (13%) students were neutral.

The majority of students agreed or strongly agreed that the syllabus is sufficient to make them analyze problems and their suitable solutions. However, a significant percentage of students were neutral or disagreed with the statement. 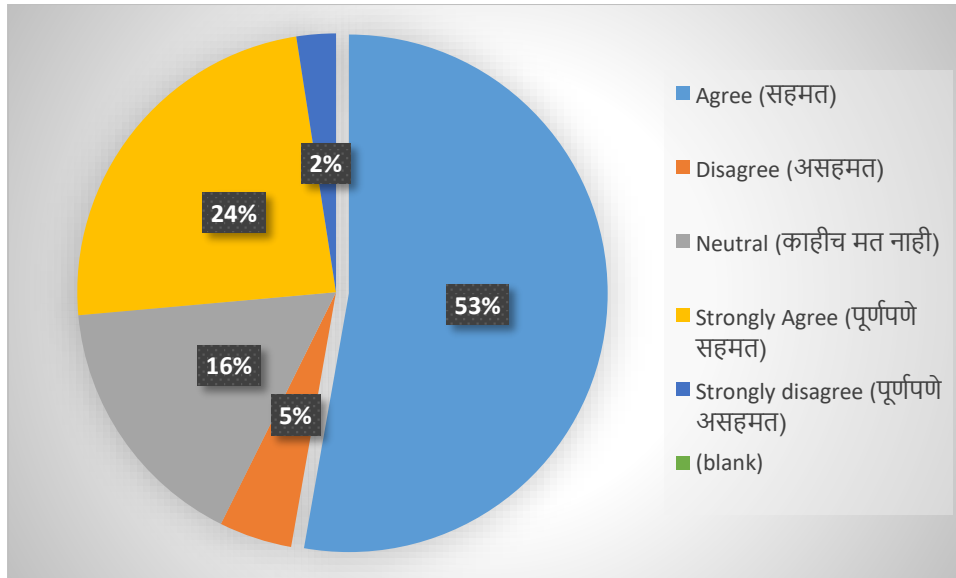

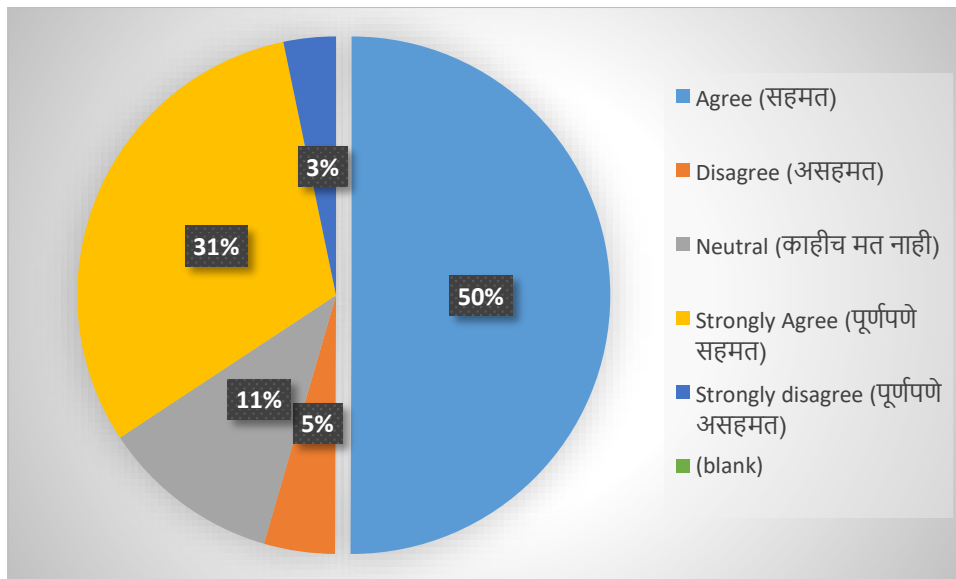
Based on the responses received from the students, it can be analyzed that a majority of them agree that the electives offered in the program are relevant to their specialization and match the current scenario in industry. Out of the 3092 students, 71.64% (2213) of the students agreed that the electives offered in the program are relevant to their specialization, and 74.13% (2273) of the students agreed that the electives match the current scenario in industry.

However, a significant number of students either disagreed or had a neutral response to both statements. 4.56% (141) of the students disagreed that the electives are relevant to their specialization, and 4.83% (149) of the students disagreed that the electives match the current scenario in industry. Additionally, 16.23% (502) of the students had a neutral response to the statement that the electives match the current scenario in industry, and 17.09% (525) had a neutral response to the statement that the electives are relevant to their specialization.

Overall, while a majority of the students agreed with the statements, a significant number of students either disagreed or had a neutral response, indicating that there may be room for improvement in the relevance and matching of electives to the current industry scenario.

According to the responses received from the students, the majority of them agree that the reference books and journals justify the course and are available in the library. The percentage of students who agreed and strongly agreed is 63.62% (1548+959), which is more than the percentage of students who disagreed and strongly disagreed (6.81%, 137+101) and neutral (11.21%, 347) respectively.

This indicates that the availability and relevance of reference books and journals in the library to the course is satisfactory. However, it is noteworthy that around 11.21% of students expressed a neutral opinion, suggesting that some students might need more information or exposure to resources to evaluate the availability of relevant reference materials.

Overall, the result indicates that the library has a good collection of reference books and journals, which supports the course material, and students are satisfied with it.

### Objectives:

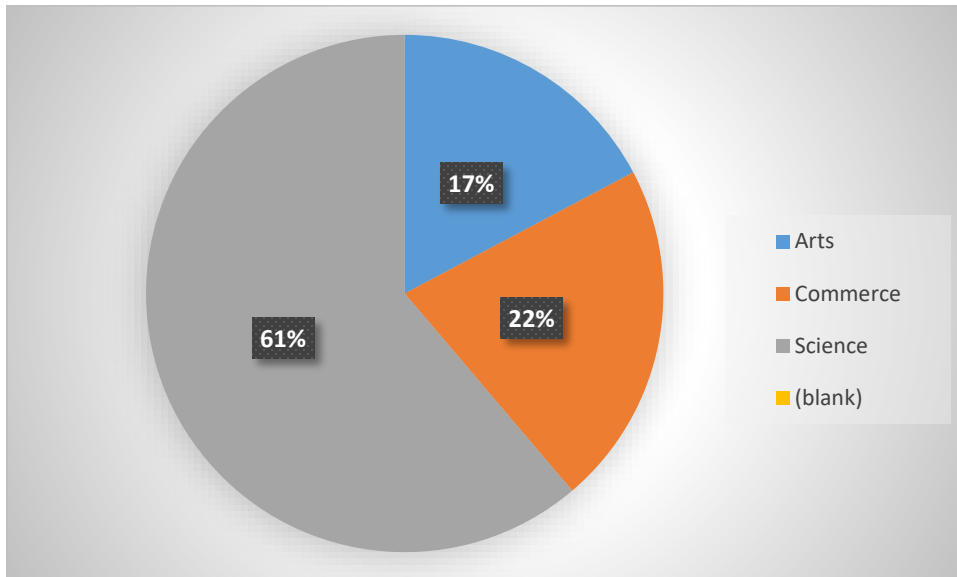
1. To make sure the curriculum is relevant and advantageous for students, evaluate how well it complies with professional and academic requirements.

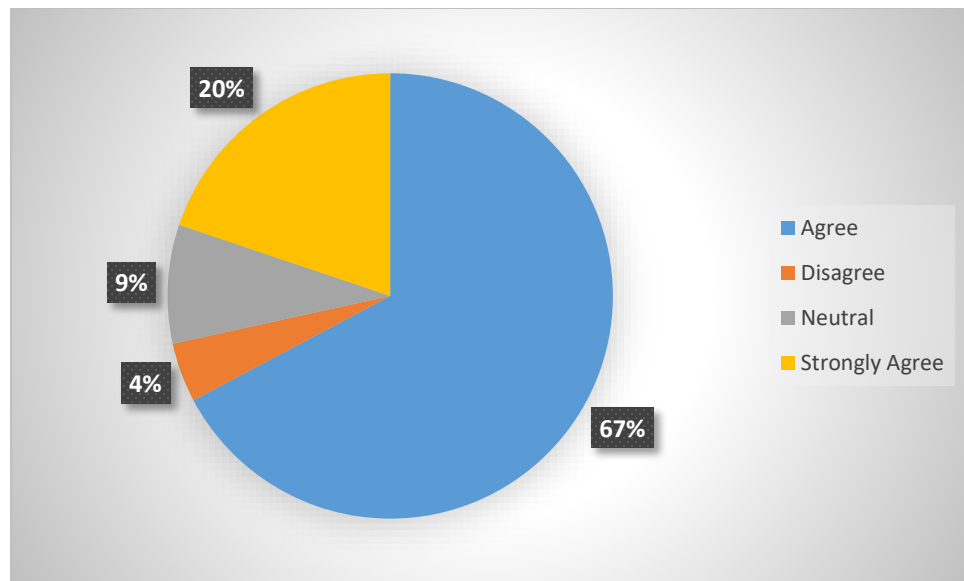

1. Whether Curriculum is designed taking into consideration the overall growth of academic & professional need of the students.

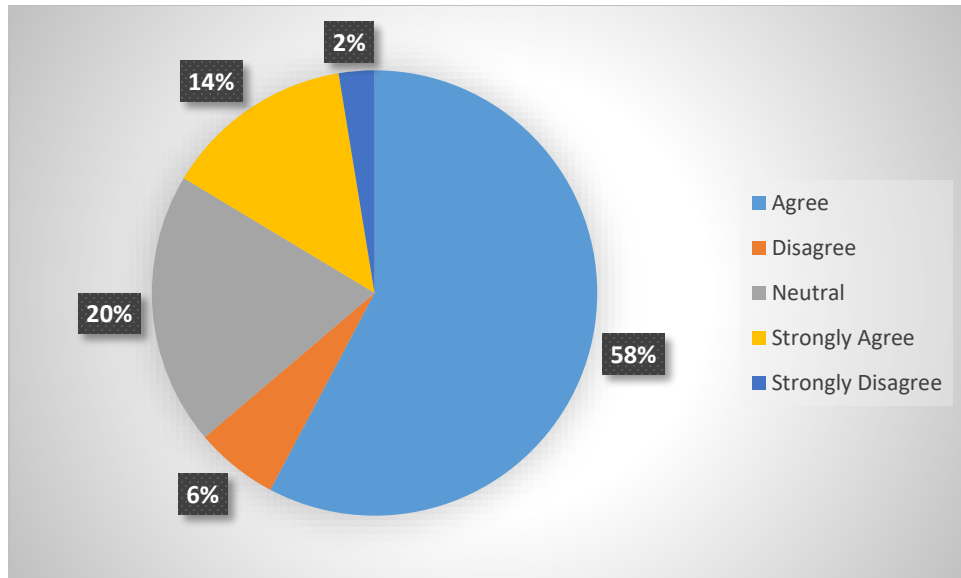

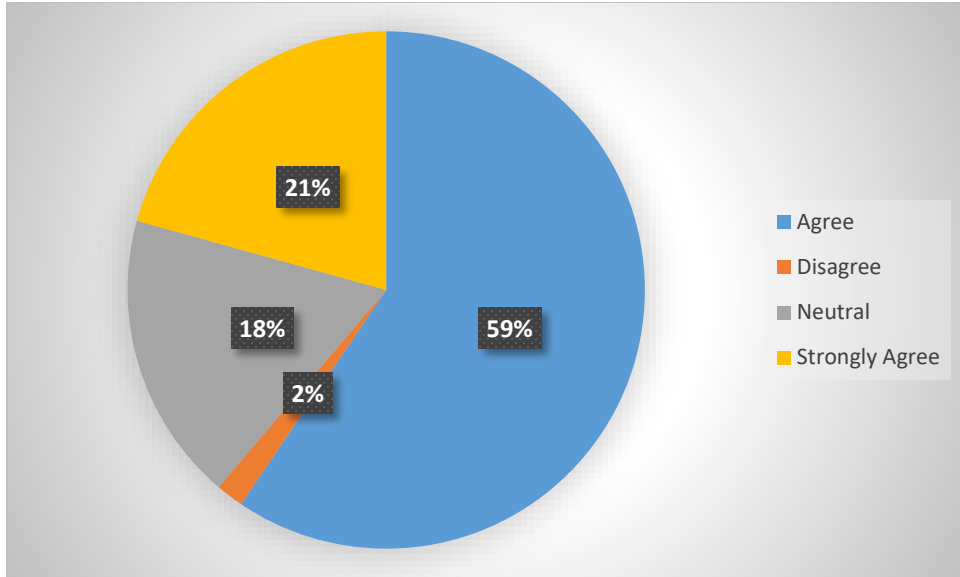
2. Whether Curriculum provides employability.

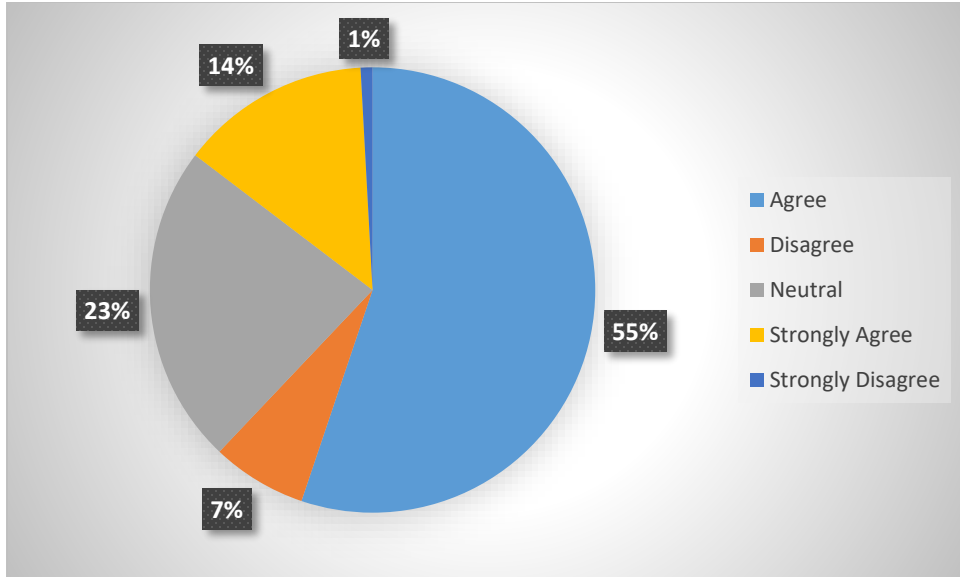
3. The curriculum needs considerable revision (More than 50%).

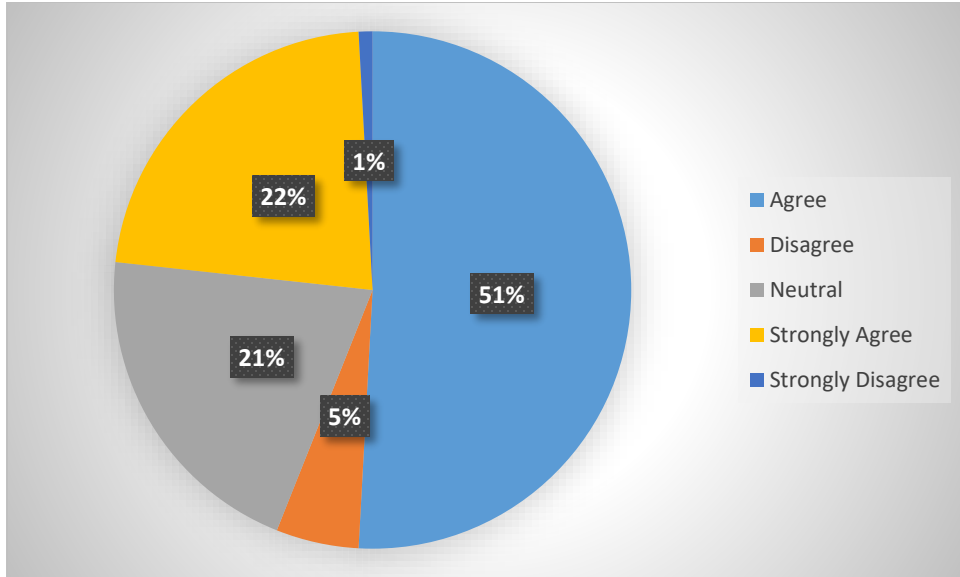

The Minutes of the Meeting were recorded in writing by Prof. Mahesh Deshmukh, IQAC Co-Ordinator on 25<sup>th</sup> July 2022.

### **Agenda 1. Approve the minutes of the previous meeting**

The Minutes of the previous meeting were read before the members for discussion and review. After discussion, minutes were approved and documented for future reference.

### **Agenda 2. To review the action taken report of the previous meeting.**

The chairman approved the action taken report to the members for review purposes. The progress and status of each action were reviewed by the members to ensure accountability, transparency, and continuous improvement in the implementation of decisions and actions for enhancing the quality benchmarks.

### **Agenda 3. To revisit the Vision and Mission of the institute, SOP's considering changing the education ecosystem and implementation of NEP 2020.**

Mr. Mahesh Deshmukh presented a comprehensive review of the Vision and Mission of the institute, aligning them with the goals outlined in the National Education Policy (NEP) 2020. Members discussed the need for adaptability and innovation to accommodate changes in the education ecosystem. Members shared insights on effective teaching methods, student engagement strategies, and the integration of technology in education. Vision and Mission statements and to be placed to CDC for final approval and adoption. Further, the standard operating procedures were reviewed, revised and sent to various departments for feedback, post which it was to be placed before the CDC for approval.

### **Agenda 4. To place and review the proposal for conducting various audits for the academic year 2022-23.**

The Chairman & Principal Dr. Kiran Save presented a proposal for conducting academic and environmental audits for the academic year 2022-23. This included green audits, energy audits, and academic audits alongside statutory audits. The members also recommended going for a gender audit, and human resource audit for the first time alongside move towards sustainability impact assessment. The timeline for each audit was also discussed. The proposal was discussed, and it was agreed to proceed with the audits as outlined in the proposal to CDC for final approval.

### **5. To identify and prepare a plan of action for best practices to strive during the academic year.**

The IQAC coordinator provided an overview of SDG 3 and SDG 13, emphasizing the relevance of health and well-being, as well as climate action, within the academic context. Members discussed how the institute could contribute to these goals through its educational practices. The committee collaboratively developed a plan of action to implement the identified best practices. This included:

- Integrating menstrual health and hygiene and mental health into the educational framework.
- Promoting eco-friendly initiatives such as waste reduction, energy conservation, and green spaces on campus.
- Collaborating with local health organizations and environmental groups.
- Implementing awareness campaigns on health and climate issues.

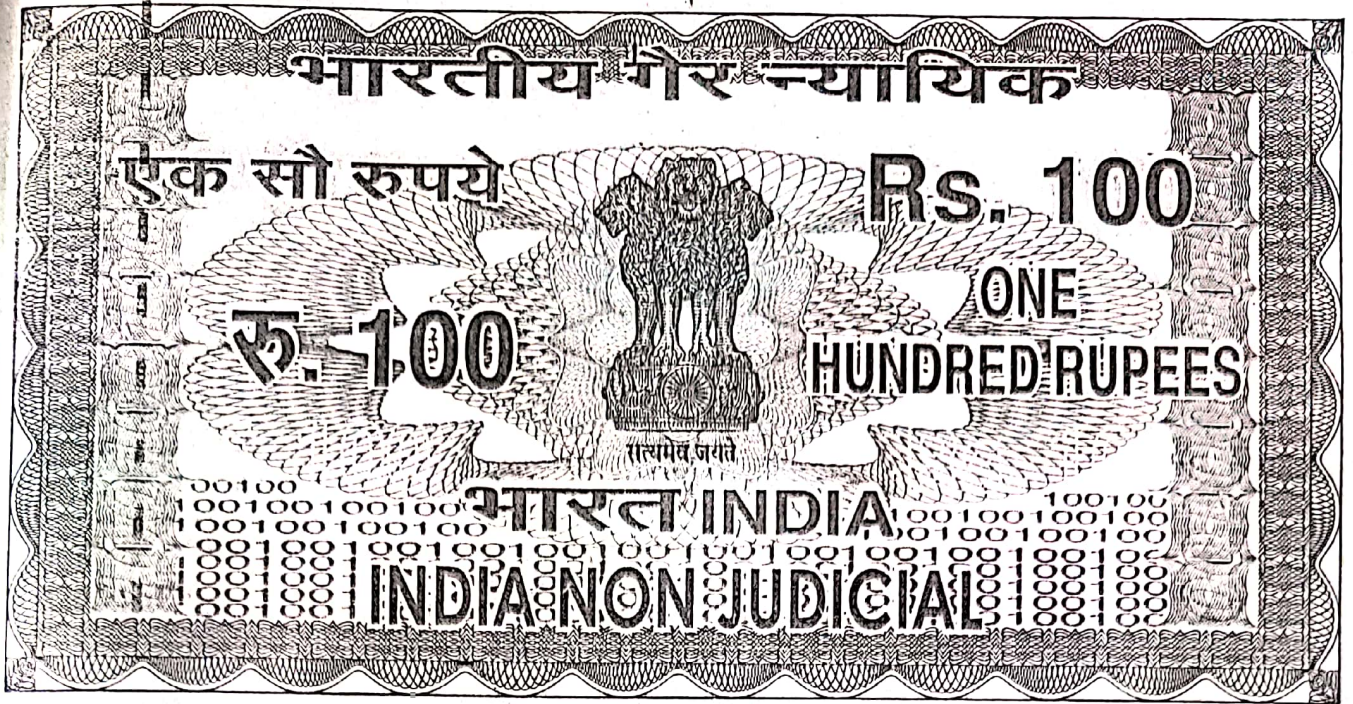

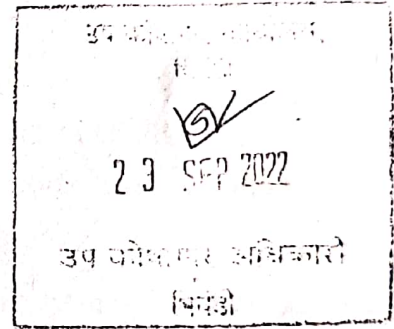

Palghar 401 605, the First Party represented herein by its Principal Dr. Yogesh K. Patil (hereinafter referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

Department of Geography of Sonopant Dandekar Shikshan Mandali's Sonopant Dandekar College Palghar, Dist-Palghar 401404, and represented herein by its Principal Dr. Kiran J. Save (hereinafter referred as 'Second Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns)

WHEREAS:

- A) First Party is a Higher Educational Institution named:
  - (i) Name of Institution: Sanjeevan Gramin Vaidyakiya and Samajik Sahayata Pratishtan's Arts, Commerce and Science College, Onde, Tal.Vikramgad, Dist. Palghar 401 605
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Faculty Exchange Programme, Skill Development, Student Exchange Programme, R&D Services and Related Services.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) Sonopant Dandekar Shikshan Mandali's Sonopant Dandekar College Palghar, Dist-Palghar 401404 the Second Party is engaged in Education fields.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS:

**CLAUSE 1  
CO-OPERATION**

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Sanjeevan Gramin Vaidyakiya and Samajik Sahayata Pratishtan's Arts, Commerce and Science College, Onde, Tal. Vikramgad, Dist. Palghar 401 605** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the laboratory, the Second Party.

1.3 The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 2  
SCOPE OF THE MoU**

2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of a laboratory. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the laboratorial scenario meaningfully.

2.3 **Laboratory Training & Visits:** Laboratory and Institution interaction will give an insight in to the latest developments / requirements of the laboratories; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Training Programs for the First Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to

have a smooth transition from academic to working career. The Second Party will provide its Labs for the hands-on training of the learners enrolled with the First Party.

**2.4 Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of Geography.

**2.5 Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them laboratory ready. Students can volunteer in blood donation camp activities and assist the blood bank staff.

**2.6 Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.

**2.7 Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the laboratory requirement considering the National Occupational Standards in concerned sector, if available.

**2.8** Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein. There is no financial commitment on the part of the **Sanjeevan Gramin Vaidyakiya and Samajik Sahayata Pratishtan's Arts, Commerce and Science College, Onde, Tal.Vikramgad, Dist. Palghar 401 605** the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### CLAUSE 3

#### INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### CLAUSE 4

#### VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Department of Geography, Sanjeevan Gramin Vaidyakiya and Samajik Sahayata Pratishtan's Arts, Commerce and Science College, Onde, Tal.Vikramgad, Dist. Palghar 401 605**, the First Party, as the case may be, will take effective steps for implementation of this MoU or, **Sonopant Dandekar Shikshan Mandali's Sonopant Dandekar College Palghar, Dist-Palghar 401404**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU.

4.2 Both Parties may terminate this MoU upon 30 calendar day's notice in writing. In the

event of termination, both parties have to discharge their obligations.

## CLAUSE 5

### RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that Department of Geography, Sanjeevan Gramin Vaidyakiya and Samajik Sahayata Pratishtan's Arts, Commerce and Science College, Onde, Tal. Vikramgad, Dist. Palghar 401605 and Department of Geography, Sonopant Dandekar Shikshan Mandali's Sonopant Dandekar College Palghar, Dist-Palghar 401404, are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.






